- 6. Electronic bids must be submitted through PPMO's e-GP system <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 PM on April 1, 2020. Bids received after this deadline will be rejected.
- 7. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM, April 1, 2020 at the office of Machhapuchhre Rural Municipality, Lahachowk, Kaski. Bids must be valid for a period of 90 Days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of

e-bid,\amounting to NRs. Mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
