- 1. The Machhapuchhre Rural Municipality, Office of the Rural Municipal Executive invites sealed quotations from registered Suppliers for the supply, delivery and installation of Supply and Installation of solar Power System.
- 2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Machhapuchhre Rural Municipality, Lahachowk, Kaski [Email: mpgaupalika@gmail.com, Phone: 9856017310, Website: www.machhapuchhremun.gov.np]
- 3. A complete set of Bidding Documents may be purchased from the Office of Machhapuchhre Rural Municipality, Lahachowk, Kaski by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs.** 1000.00 till 2077/02/28 during office hours.
- 4. Sealed bids must be submitted to the office Machhapuchhre Rural Municipality, Lahachowk, Kaski by hand on or before **12:00 noon** on **2077/02/29**. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM** on **2077/02/29**, at the office of Machhapuchhre Rural Municipality, Lahachowk, Kaski. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **NRs. 24,000.00**, which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. **16600101092234000004** at **Prabhu Bank Limited, Lahachowk Branch** and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 7. Photovoltaic (PV) panel, battery and Charge controller should be RETS certified.
- 8. Warranty of each component should be provided. Minimum 10 years of warranty for Photovoltaic (PV) Panel and minimum 3 years of warranty for Charge Controller and Battery must be provided by the bidders.
- 9. Repair and Maintenance after installation within 1 years should be provided by the bidders.
- 10. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
